[Nonpoint Source Pollution \(NPS\) Control Program](#)

The NPS Program administers grant money it receives from United

States Environmental Protection Agency through Section 319(h) of the Federal Clean Water Act and from the state Timber Regulation and Forest Restoration Fund. These grant funds can be used to implement projects or programs that will help to reduce NPS pollution. Projects that qualify for funding must be conducted within the state's NPS priority watersheds.

[California Coastal Commission Whale Tail Grants](#) WHALE TAIL®

grants support experiential education and stewardship of the California coast and its watersheds. Education and stewardship projects relating to climate change as it impacts the coast and ocean are eligible and encouraged. Shoreline cleanup and coastal habitat restoration projects that have an educational component are also eligible for these grants. Application deadline is **November 5th**.

[State Coastal Conservancy Coastal Stories Grant Program](#). SCC seeks to fund projects that plan, develop, and implement storytelling installations or materials (such as murals, signage, monuments, or guides) that represent communities and voices that may include but are not limited to BIPOC people, people with disabilities, immigrant communities, low-income communities, and other historically excluded communities. They encourage proposals for community-led projects that show strong community and landowner partnerships and use creative forms of historical, ecological, and cultural storytelling. The Conservancy will hold an informational webinar on **Tuesday, November 16, 2021, 12 pm - 1pm** to walk through the Coastal Stories Grant Program and address common questions regarding the application.
