<u>California Central Coast Joint Venture (C3JV)</u> is interested in learning more about conservation on the Central Coast. 4C is proud to support C3JV, whose mission is to work through inclusive partnerships advancing strategies that steward healthy and resilient habitats for birds, other wildlife, and people.

The C3JV works to advance conservation efforts within six habitat systems that each have unique assemblages of species, pressures acting on them, and people engaged in their stewardship. Key avian focal species are then used as indicators to help the Joint Venture monitor and assess our conservation impact over time within each habitat system. Learn more about C3JV here.
