Governor Newsom Signs Historic 2022-2032 Budget

Last week, Governor Newsom's budget signing marked the formal establishment of the <u>Office of Community Partnerships and Strategic Communications (OCPSC)</u> under the Governor's Office of Planning and Research.

Regional Climate Collaboratives Round 1 Full Application Available The Strategic Growth Council invites Full Applications for Round 1 of the Regional Climate Collaboratives (RCC) Program. RCC funds community-rooted and cross-sectoral partners to deepen their relationships and develop the processes, plans, and projects that will drive and sustain climate action. The goal of the program is to strengthen local coordination, leadership, knowledge, skills, and expertise with a particular focus on increasing access to funding resources for project planning and implementation within under-resourced communities. NOAA Transformational Habitat Restoration and Coastal Resilience Grants \$85 million in funding is available for transformational habitat restoration and coastal resilience projects in FY2022 under the Bipartisan Infrastructure Law (Infrastructure Investment and Jobs Act).

NOAA Coastal Habitat Restoration and Resilience Grants for Underserved Communities \$10 million in funding is available for habitat restoration and resilience awards for underserved communities in FY2022 under the Bipartisan Infrastructure Law (Infrastructure Investment and Jobs Act).

NOAA Marine Debris \$56M available for Marine Debris removal projects. Full proposals must be submitted through and validated by Grants.gov on or before 11:59 p.m. ET, September 30, 2022. More information here
