### In Climate News...

**Coastal Conservancy Strategic Plan: The State Coastal Conservancy** has kicked off its **2023-2027 Strategic Plan update** and will be seeking input over the next six months and would like to hear your thoughts about your experience working on coastal projects; your priorities around coastal resilience and public access; and how we can do work to make our programs and resources more accessible to a wider audience. If so, we have great news -- you can now "check out" a free pass to California State Parks at your local public library! The First Partner's Office and the California State Library have partnered to bring safe and equitable access to state parks and open spaces for all Californians with a library card. The pass allows one passenger vehicle of nine or fewer or one state licensed motorcycle free entry to over 200 parks across the state. **OPC: Coastal Habitats Program Manager:** The California Ocean Protection Council (OPC) is hiring an Environmental Scientist to help lead its efforts to conserve coastal watersheds and habitats, including wetlands, eelgrass, beaches, dunes, and rocky intertidal. The Environmental Scientist will advance these strategic priorities in coordination with OPC staff, state and federal agencies, Tribes, local

governments, scientists, non-profits, community members and others. The Environmental Scientist will also be responsible for grant and contract management including developing scopes of work and budgets, tracking deliverables, and coordinating with grantees. **Environmental Program Officer- Thriving Communities:**

As an Environmental Program Officer, you are responsible for taking a strategic approach to the development, research, implementation, and execution of Patagonia's environmental funding programs with an emphasis on civic engagement, environmental justice and underrepresented communities in the environmental movement and outdoor industry. Your role focuses on fostering relationships with prospective and ongoing grantees, strategic development and execution of relevant programs and funding initiatives, and engaging employees as key stakeholders throughout the grantmaking process.

**Cannabis Restoration Grant Program:** Proposals to enhance watersheds and communities should solicit funds for, but not limited to: road decommissioning, road crossing upgrades, erosion and sediment delivery prevention actions, culvert upgrades, water conservation, cleanup and remediation of impacts of illicit cannabis operations on private lands, and/or enhancing biodiversity and wildlife habitat within watersheds, among other projects of similar nature.

**Local Coastal Program Non-Competitive Grant Applications:** The Coastal Commission is offering rolling grant funding to support local government coastal resiliency efforts. Funds may be used for projects that are designed to assist local governments in assessing impacts and planning for coastal resiliency, including adapting to the impacts of climate change and sea level rise, and which contain an LCP planning component. Local governments responsible for developing and amending LCPs under the California Coastal Act are eligible to apply. [More information here.](#)

**CDFW 2022 Endangered Species Conservation and Recovery Habitat Conservation Planning Assistance Grant Program:** The Endangered Species Habitat Conservation Planning Assistance (HCPA) Grant Program provides funding to states and territories for tasks necessary in the planning, amendment, or renewal phases of an HCP, such as baseline surveys and inventories, preparation of planning and environmental documents, and outreach. The Service will consider Proposals supporting efforts to amend and renew existing HCPs or HCP/NCCPs. [More information here.](#)

**Transferable Strategies for Coastal Resilience Projects: Best Practices and Lessons Learned | Thursday, May 26, 2022 | 1:00pm to 2:00pm |** The National Fish and Wildlife Foundation (NFWF) commissioned ERG to gather and share best practices from coastal resilience practitioners on enhancing implementation of coastal resilience efforts across the United States. The project encompassed review of more than 100 source documents including NFWF grant project reports and peer-reviewed literature, as well as interviews with resilience practitioners. ERG used their research findings to develop eight case studies documenting successful projects throughout the country. The case studies highlight transferrable strategies for resilience projects ranging from conducting ongoing monitoring of the project site to leveraging resources to build local capacity to testing novel approaches. This webinar is designed to help resilience practitioners learn about solutions and approaches from teams

implementing these projects. Sharing of best practices and lessons learned will focus on partnership building, outreach and engagement, and highlight adaptive management transferrable strategies. [Register Here.](#)

**EPA Nonpoint Source Program Conversation with Community Organizations | May 24-25, 2022** | Please join the Environmental Protection Agency (EPA) for one of the last two listening sessions May 24th and May 25th, focused on equity and inclusion in the National Nonpoint Source (NPS) program. This discussion will cover anyone who is a subgrantee or is considering applying for an NPS Clean Water Act (CWA) Section 319 grant. This listening session will provide an overview of the NPS program and the Justice40 initiative, updates on EPA's efforts to incorporate the Justice40 initiative into its NPS program, and a facilitated discussion with subgrantees. This discussion aims to understand the challenges facing environmental justice communities, Tribes, and Indigenous communities, how these challenges impact NPS programs working within these communities, and how EPA can help address these challenges through action in the CWA Section 319 programs. Specific project types include research-based projects that focus on coastal habitat mapping, contaminated sites, and socio-economic impacts, and implementation projects that work to provide resilience to climate change through restoration and/or habitat enhancement.
