

# In Climate News...

The <u>Uplift Central Coast Coalition</u> was awarded the \$5 million grant through <u>California's Community Economic Resilience Fund (CERF)</u>.

The Pájaro Valley is one of 10 grant recipients from the state's **Transformative Climate Communities (TCC) program**, which recently approved \$96.2 million in grants to support disadvantaged, unincorporated and tribal communities across California to plan and implement neighborhood-level projects that reduce greenhouse gas emissions, improve public health and the environment and expand economic opportunity for residents. As lead applicant on "Climate Prosperity for Pájaro Valley," the <u>County of Monterey</u> collaborated on the application

with <u>Regeneración</u> (Regen), <u>Ecology Action</u>, and the <u>Association of</u> <u>Monterey Bay Area Governments</u> (AMBAG).

The Land Resilience Partnership has released the Drought Resilient Communities Campaign toolkit for the Central and Southern CA coastal regions to catalyze accelerated drought response for immediate home landscape transformation that will save millions of gallons of water while increasing drought awareness, environmental resilience, habitat value, and community health.

ICARP's <u>Climate Services</u> team launched the <u>Climate Resilience Plan</u> <u>Alignment Toolkit</u> on the Adaptation Clearinghouse to support local and regional planning. The Toolkit features a new Wildfire Guide and Flood-After-Fire Guide, as well as the original Coastal Compass Guide released in 2018. ICARP will host an <u>informational webinar</u> on December 7, 2022, at 11am. <u>Register here</u>.

Governor Newsom signed an <u>executive order</u> directing state agencies and departments to take additional actions to embed equity analysis and considerations in their mission, policies and practices. The executive order also established a new Racial Equity Commission in the Governor's Office of Planning and Research (OPR). More information <u>here</u>.

The Office of Environmental Health Hazard Assessment (OEHHA) has released the fourth edition of the report: <u>Indicators of Climate Change in</u> <u>California</u>. Summary is <u>here</u>.

EPA's <u>Request for Information (RFI)</u> seeks public comment on core design aspects of multiple Inflation Reduction Act programs, a crucial first step as the Agency works to implement historic levels of funding from this legislation. These initial engagements will help ensure the design and implementation of the programs reflect input from a broad coalition of stakeholders to ensure the full economic and environmental benefits of this historic investment are realized by all people, particularly those who have been most burdened by environmental, social, and economic injustice. <u>Comments</u> are due by January 18, 2023.

# **Funding Opportunities**

**2022** Mosaic Movement Infrastructure RFP \$5.5 million RFP to support local to national movement infrastructure that enhances diverse and collaborative implementation of four key statutes and initiatives – the Inflation Reduction Act, Bipartisan Infrastructure Law, Justice40, and 30x30. **Due December 9, 2022.** <u>Apply here</u>

T h e <u>UC-CSU</u> Environmental and Climate Change Literacy Projects (ECCLPs) is an innovative partnership between the UC and CSU systems and community-based partners (CBPs), to advance prekindergarten through 12th grade (PK-12) climate and environmental literacy, justice, and action. The ECCLPs Executive Committee is seeking partnerships and collaborations by launching <u>ECCLPs</u> Climate and <u>Environmental Justice Literacy Initiatives</u> with the collective goal to educate all of California's high school graduates to be literate in climate change and environmental justice issues and solutions.

CAL FIRE will open the FY 2022-2023 Forest Health grant solicitation on December 15, 2022. Final grant guidelines, applications, supporting documents, and a recorded workshop will be posted on the Forest Health Grantees Resources web page. Application will be due by **3pm on February 28, 2023**.

**ICARP Adaptation Planning Grant Program**. This program provides funding to help fill local, regional, and tribal planning needs, provides communities the resources to identify climate resilience priorities, and supports the development of a pipeline of climate resilient infrastructure projects across the state. Each project team, must complete the <u>intent</u> **survey** to indicate intent to apply for a Round 1 APGP grant. This survey is also a requirement for prospective Applicants to gain access to an individualized SharePoint folder where all application materials will be uploaded before **March 31, 2023**.

<u>State Coastal Conservancy Coastal Resilience Funding</u>. The State of California has made an unprecedented investment in the resilience and accessibility of the coast. As a result, the <u>Coastal Conservancy</u> has significant funding available to non-profit organizations, public agencies, and federally-recognized tribes for projects that benefit public access, natural resources, working lands, and climate resiliency at the coast, coastal watersheds, and the San Francisco Bay. They anticipate that the majority of the funding will be allocated through SCC's ongoing pre-proposal solicitation. To learn more about this process, please visit the here.
