Funding and Job Opportunities

The Employment Development Department in collaboration with the Labor and Workforce Development Agency, the Governor's Office of Planning and Research and the Governor's Office of Business and Economic Development has announced the availability of up to [\\$50 million in the CERF Economic Development Pilot Program](#). Full details on this program can be found [here](#). The deadline to submit proposals is **Monday, February 13th by 3pm** and applicants are encouraged to submit a notice of intent to apply by **5pm on January 23rd**.

Biden-Harris Administration Announces Availability of \$100 Million through Inflation Reduction Act for Environmental Justice Grants. The [EJG2G Program](#) (formerly known as the State Environmental Justice Cooperative Agreement program) will provide an estimated \$70 million in funding. Of this, \$20 million will be for State governments to be used in conjunction with Community-Based Organization (CBO) partners, \$20 million will be for local government with CBO partners, \$20 million will be for Federally Recognized Tribal Nations with CBO partners, and \$10 million will be for U.S. territories and remote tribes with limited access to CBO partners. In total the Agency anticipates funding approximately 70 projects of up to \$1 million each for a 3-year project. Applicants interested must submit proposal packages on or before **April 10, 2023**, to be considered for the available funding. Applicants should plan for projects to begin on **October 1, 2023**. The [UC–CSU Environmental and Climate Change Literacy Projects](#) (ECCLPs) is an innovative partnership between the UC and CSU systems and community-based partners (CBPs), to advance prekindergarten through 12th grade (PK–12) climate and environmental literacy, justice, and action. The ECCLPs Executive Committee is seeking partnerships and collaborations by launching [ECCLPs Climate and Environmental Justice Literacy Initiatives](#) with the collective goal to educate all of California's high school graduates to be literate in climate change and environmental justice issues and solutions.

CAL FIRE will open the FY 2022-2023 Forest Health grant solicitation on December 15, 2022. [ICARP Adaptation Planning Grant Program](#). This program provides funding to help fill local, regional, and tribal planning needs, provides communities the resources to identify climate resilience priorities, and supports the development of a pipeline of climate resilient infrastructure projects across the state. Each project team, must complete the [intent survey](#) to indicate intent to apply for a Round 1 APGP grant. This survey is also a requirement for prospective Applicants to gain access to an individualized SharePoint folder where all application materials will be uploaded before **March 31, 2023**.

[State Coastal Conservancy Coastal Resilience Funding](#). The State of California has made an unprecedented investment in the resilience and accessibility of the coast. As a result, the [Coastal Conservancy](#) has significant funding available to non-profit organizations, public

agencies, and federally-recognized tribes for projects that benefit public access, natural resources, working lands, and climate resiliency at the coast, coastal watersheds, and the San Francisco Bay.
