News and Updates

A collaboration between <u>The FUND</u>, a Native-led consulting firm, <u>Evolve Equity</u>, and researchers from UCSB and USC, the initiative began in late 2021 with the completion of a regional equity study and report, <u>Toward a Just and Equitable Central Coast</u>, which centers around Eleven Principles and Priorities for Research and Action–number one being "Respect the rights and experiences of Indigenous people."

In 2021 the Ocean Protection Council (OPC) released their <u>Kelp Action Plan</u> containing strategies and opportunities to address the kelp crisis proactively. This included the launch of a statewide <u>Kelp Recovery Research Program</u> through which OPC and California Sea Grant, in coordination with the California Department of Fish and Wildlife (CDFW), solicited proposals for "solutions-oriented" projects that would directly inform the efforts of resource managers to protect and restore kelp ecosystems statewide. Results from those projects are now available <u>here</u>.

Funding and Job Opportunities

Indigenous Ways of Knowing in Decision-Making RFP: On July 10, Lenfest Ocean News will open a RFP for elevating Indigenous ways of knowing in decisions Indigenous people have been historically excluded from. More information is available through their newsletter.

OPC is seeking applicants to help develop the <u>Senate Bill 1</u> <u>Technical Assistance Program (SB 1 TA Program</u>). The goal of this first-ever <u>OPC TA Program</u> is to provide direct application services to qualified SB 1 Grant Program applicants to ensure equitable access to sea-level rise planning funds and coastal resilience resources. See the <u>Request for Proposals</u> for full details on this funding opportunity. The maximum amount for this project must not exceed a total of \$1,000,000. Due **July 13, 2023 by 5PM**.

The Strategic Growth Council (SGC) has made \$8.5 million in funding available through the **Regional Climate Collaboratives** (RCC) **program**, which is part of the Community Assistance for Climate Equity suite of programs. The RCC program funds cross-sectoral partnerships to build capacity for climate mitigation, adaptation, and resilience within under-resourced communities. Grantees will use the funds to strengthen local coordination, leadership, knowledge, skills, and expertise with a focus on increasing access to funding for project planning and implementation. Regional Resilience Planning and Implementation Grant Program ICARP has published the final guidelines and application materials for the Regional Resilience Grant's first round of funding (\$9.4 Million). The first step to applying for the Regional Resilience Grant is filling out the Intent to Apply Survey. The sooner you complete the survey, the sooner RRGP will send you access to the application. Applicants must submit their complete applications on August 29, 2023 by 5:00PM

Solicitation to Fund Core Climate Research for California's Fifth Climate Change Assessment

The California Institute for Energy and Environment at the University of California, Berkeley, in partnership with the California Natural Resources Agency, has announced a new solicitation (RFP) to fund research that fills critical gaps in the scientific literature related to

understanding and adapting to climate change impacts in California. Submissions are due **July 17**, **2023 by 5:00PM** PTD and should be submitted electronically to ccca@berkeley.edu.

The National Oceanic and Atmospheric Administration (NOAA) has released the Notice of Funding Opportunity for up to \$575 million to help coastal communities increase their resilience to extreme weather events and impacts from climate change. The funds are available through the competitive Climate Resilience Regional Challenge, managed by the NOAA Office of Coastal Management, and provided by the Inflation Reduction Act. The program aims to invest in collaborative, regional approaches to climate resilience, with an emphasis on equity, adaptation, and building enduring capacity. The closing date for letters of intent is August 21, 2023. Direct questions to resiliencechallenge@noaa.gov.
